Dear Readers,

During this period the charity continued to develop its network of contacts and organisations that could be useful to the charity in achieving its objectives.

According to its foundation principles, Children's Hearts continued to endeavour to provide funds to buy specific items of equipment used in the open-heart operations for children on individual basis.

During the year Children's Hearts continued to co-operative relationship with a company Audosta Ltd in the UK that donated to the charity on a regular basis throughout the year. The charity also grateful to the support from members of the public supporting us via donations and via online platforms such as Justgiving.

We also received some donations from various organisations and sponsors during the year, which enabled us to accumulate funds for future life-saving support for children with congenital heart defects.

The charity continues to pursue fund-raising and information disseminating activities in order to support its following main activities set in the founding principles:

- Fund raising for live saving heart operations for children
- Providing help to improve knowledge and skills as well as exchange of information between surgeons internationally in order to keep abreast of new developments in the cardiology
- Providing educational materials to parents, general practitioners and maternity ward doctors on congenital hearts defects in children and ways of early diagnostics, coping with pre- and post-operational problems and rehabilitation practices

In 2022/2023 the charity received many enquiries from various countries, with parents or their representatives asking for help for children with congenital heart defects. The charity, however, has very limited available funds so, unfortunately, it was only possible to support selected few cases.

We thank all people and organisations that donated and helped Children's Hearts in the past year.

Report of The Independent Examiner On The Accounts For the Year Ended 4 December 2023 To The Trustees And Members of Children's Hearts Trust Registered Charity No. 1082929

I report on the accounts of the Trust for the year ended 04 December 2023, which are presented on a separate page.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

It is my responsibility to:

- examine the accounts under section 145 of the 2011 Act;
- to follow the procedures laid down in the general Directions given by the Charity Commission under section 145(5)(b) of the 2011 Act; and
- to state whether particular matters have come to my attention.

Basis of independent examiner's report

My examination was carried out in accordance with the general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently no opinion is given as to whether the accounts present a 'true and fair view' and the report is limited to those matters set out in the statement below.

Independent examiner's statement

Shadrack KAWALYA, from Uganda

Date of birth 23.02.2021.



Shadrack was born with a complex congenital heart defect. After suffering from constant fatigue, rapid breathing, excessive crying and a blue tinge to the skin and lips, he was inspected by doctors at the Uganda Heart Institute - Mulago, and was diagnosed with Situs Solitus, Levocardia. Initially, the child was under the supervision of the Uganda Heart Institute -Mulago. Unfortunately, the defect did not naturally cease and an open-heart surgery was suggested as the only way to save the life of Shadrack. It was not possible to perform such an operation in Uganda due to lack of medical equipment and surgeons who perform the heart operation. recommended that the operation should performed elsewhere outside Uganda where facilities allow such surgeries to be performed. The family of the child lives in a remote village in Mubende District in Central Uganda and could not afford the costs of the life-saving operation. The family and the Mubende Kids Alive Ministry identified a clinic in India where such surgery could be performed.

Children's Hearts charity (UK), jointly with the family and Mubende Kids Alive Ministry supported the child to have a life-saving operation in India and Shadrack with his mother went to India for this open-heart surgery for the boy.

The operation was successfully performed at the Fortis clinic, Shalimarbagh, New Delhi, India by Dr.Dinesh Kumar Mittal in May 2023 (planned surgery for VSD closure + PDA ligation).

The operation was successful, the pre-discharge echo investigation was done on 16.5.23 and the child was discharged in a stable condition. The recovery went well and Shadrack is now back home in Uganda together with his family.

Children's Hearts charity (UK) was happy to support the life-saving CHD procedure for the child and contribute to the life-saving operation for Shadrack Kawalya.

Shadrack is now is back in Uganda with his family and this was the family's dream come true! We wish Shadrack all the best and a happy life!
